2.0 Hazards identification

4.0 First aid measures

4.1 General information

As a general rule, in case of doubt or if symptoms persist, always call a doctor. NEVER induce swallowing in an unconscious person.

4.2 In the event of exposure by inhalation

In the event of dust formed by mechanical action (sanding, sawing, etc..), this dust may cause irritation by inhalation and contact with eyes. If a large quantity is inhaled, move the patient into the fresh air and keep him/her warm and still.

If breathing is irregular or has stopped, effect mouth-to-mouth resuscitation and call a doctor. $\,$

Do not give the patient anything orally.

4.3 In the event of splashes or contact with eyes

Wash thoroughly with soft, clean water for 15 minutes holding the eyelids open. Refer the patient to an ophthalmologist, in particular if there is any redness, pain or visual impairment.

4.4 In the event of splashes or contact with skin

Remove contaminated clothing and wash the skin thoroughly with soap and water or a recognised cleaner. DO NOT use solvents or thinners.

4.5 In the event of swallowing

In the event of swallowing, if the quantity is small (no more than one mouthful), rinse the mouth with water and consult a doctor. If swallowed accidentally, call a doctor to assess the need for monitoring and subsequent treatment in hospital. Show him the label.

5.0 Fire fighting measures

Chemical powders, carbon dioxide and other extinguishing gas are suitable for small fires.

5.1 Suitable extinguishing media

Carbon dioxide, chemical powders, foams, and other extinguishing gases.

In the event of fire, use specifically suitable extinguishing agents. Never use water.

5.2 Extinguishing media which must not be used for safety reasons

Water is not generally recommended since it can be ineffective; however, it can be used successfully to cool containers exposed to the fire and to disperse fumes.

A fire will often produce a thick black smoke. Exposure to decomposition products may be hazardous to health.

Do not breathe in smoke.

Prevent the effluent of fire-fighting measures from entering drains or waterways.

5.3 Special protective equipment for fire-fighters

Fire-fighting personnel are to be equipped with autonomous insulating breathing apparatus.

Due to the toxicity of the gas emitted on thermal decomposition of the products, fire-fighting personnel are to be equipped with autonomous insulating breathing apparatus.

6.0 Accidental release measures

6.1 Personal precautions

Consult the safety measures listed under headings 7 and 8.

6.2 Environmental precautions

Contain and control the leaks or spills with non-combustible absorbent materials such as sand, earth, vermiculite, diatomaceous earth in drums for waste disposal.

Prevent any material from entering drains or waterways.

6.3 Methods for cleaning up

Clean preferably with a detergent, do not use solvents.

7.0 Handling and storage

The regulations relating to storage premises apply to workshops where the product is handled.

7.1 Handling

Handle in well-ventilated areas.

7.2 Fire prevention Prevent access

Prevent access by unauthorised personnel.

7.3 Recommended equipment and procedures

Packages which have been opened must be reclosed carefully and stored in an upright position.

7.4 Storage

The floor must be impermeable and form a collecting basin so that, in the event of an accidental spillage, the liquid cannot spread beyond this area.

8.0 Exposure controls / personal protection

Use personal protection equipment as per Directive 89/686/EEC.

8.1 Technical measures

In the event of dust formed by mechanical action (sanding, sawing, etc..), this dust may cause irritation by inhalation and contact with eyes. Ensure adequate ventilation, if possible with extractor fans at work posts and appropriate general extraction.

If this ventilation is insufficient to maintain the concentration of particles and dust below the exposure limits, wear breathing apparatus. Avoid inhaling dust.

Personnel shall wear regularly laundered overalls.

If this ventilation is insufficient to maintain the concentration of solvent vapors below the exposure limits, wear breathing apparatus.

10.0 Stability and reactivity
